



1. Please share your suggestions for innovations that could be introduced in the structure and programme of the WSIS+20 Forum High-Level Event.

In 2024, a myriad of processes and initiatives at the intersection of sustainable development and Internet governance will continue to come to a head and the work of defining and defending the importance of multistakeholder engagement in Internet governance will be critical. This patchwork of efforts can be overwhelming for the global internet community seeking to stay informed and meaningfully engage in the conversation. To this end, the Forum should provide space for updates to be provided on and opportunities to feed into the GDC and Summit of the Future, in addition to the key topics that will be the focus of the WSIS+20 process.

The WSIS Forum has significant multistakeholder convening power and this exercise has drawn significant attention from many relevant stakeholders. It should capitalize on that attention and its convening authority to design a deliberate, thoughtful, and inclusive program, to help streamline stakeholder engagement with these intersecting Internet governance processes. To this end, the WSIS+ 20 Forum should explore avenues to reinforce and build upon existing efforts to empower multistakeholder processes and support work toward a free, open, interoperable, and secure Internet, including those being undertaken through the Internet Governance Forum (IGF), the Christchurch Call, and the Freedom Online Coalition.

Finally, the WSIS+20 Forum High-Level event must explore ways to translate its discussions into tangible outcomes and commitments that can be pursued and implemented after the forum. These outcomes and commitments should be available to all stakeholders and participants, have broad consensus and buy-in, and where relevant, have the support and backing needed to ensure sustainability.

2. The WSIS Forum is a UN global platform for multistakeholder implementation activities, information exchange, creation of knowledge, sharing of best practice, and to foster partnerships to advance development goals. Please suggest how the WSIS Forum can enhance its alignment with the implementation of the Sustainable Development Goals (SDGs), taking into account the outcomes of the UNGA Overall WSIS Review (A/RES/70/125).

To align more closely with the implementation of the SDGs, it will be critical that the WSIS Forum facilitates multistakeholder engagement through its processes, structure, and outcomes. By fostering a collaborative environment and bringing together perspectives from across stakeholder groups, jurisdictions, and sectors, the WSIS can identify gaps, strengths, weaknesses, opportunities, and risks that exist in achieving the SDGs. The Forum must also leverage the AI for Good Forum being organized by the ITU and organize a series of high-level and action-oriented conversations that bring together and feature key decision-makers.



Additionally, the Forum should consistently emphasize the importance of a multistakeholder and human rights-respecting approach to SDG implementation throughout its high-level messaging.

3. *Please provide your suggestions for key topics and themes that should be included in the High-Level Segment of the WSIS+20 Forum High-Level Event. These topics and themes should aim to maximize the impact and relevance of the Forum in light of current trends, while also considering the 2030 Agenda for Sustainable Development and the Overall WSIS Review conducted by the United Nations General Assembly.*

Multistakeholder governance: exploring how multistakeholder governance of the internet and other technologies advances and can enhance human rights and further advance the SDGs.

4. *Please propose some ideas on format to make the High-Level segment more dynamic and interactive.*

To ensure equitable representation and participation among diverse stakeholders, the WSIS Forum should prioritize the inclusion of civil society, the technical community, and representatives from various jurisdictions, with particular focus on participants from the Global Majority. Furthermore, the Forum should curate interactive panels featuring fewer speakers to promote more engaging discussions and foster greater gender and geographic balance. Finally, the Forum should allocate adequate time for Q&A sessions to encourage meaningful interaction and feedback from participants.

5. *How can local, national and regional activities as well as innovative cross-sectoral partnerships for implementation, become more visible at the WSIS+20 Forum High-Level Event?*

To effectively engage stakeholders and leverage existing partnerships, the WSIS Forum should initiate outreach efforts before the event to surface potential collaborations that can be amplified through parallel workshops. Additionally, the Forum should actively engage with IGF Dynamic Coalitions and Policy Networks to involve their expertise and perspectives in the planning and execution of the Forum. This collaborative approach will ensure that the WSIS Forum builds upon existing work and fosters and supports partnerships to address critical internet governance issues.

6. *How can we ensure more equal participation in the parallel workshops at the WSIS+20 Forum High-Level Event?*

To foster a more inclusive and equitable WSIS Forum, it is crucial to prioritize Global Majority participation across all aspects of the event. This includes ensuring that individuals from the Global Majority, particularly, those part of civil society, are represented on panels, have their proposals considered for workshops, and receive support for travel and visa costs. This will require adequate planning and human resources given the Forum will be held in Geneva and obtaining a visa can be a significant barrier to participation from individuals based in the Global Majority. This includes communicating if workshops have been accepted and sharing the agenda far enough in advance for individuals to decide if they will be attending.
